What are cookies?

Cookies are files or pieces of information that are stored on your computer (or other Internet-enabled devices, such as your smartphone or tablet) when you visit a website. A cookie usually contains the name of the site it came from, its own "lifespan" (i.e., how long it stays on your device) and its value, which is usually a randomly generated unique number.

Based on expiration, we can use two types of cookies on the pages: session cookies and persistent cookies. Session cookies are temporary, i.e. they remain on your device until you leave our site. Persistent cookies will remain on your device for the time shown in the table above.

Privacy information about the cookies used

Cookies are placed either by us (first-party cookie) or by a third-party (third-party cookie), as indicated in the table above.

Where personal data are processed in connection with the use of cookies, the legal basis for the processing shall be the consent of the visitor according to Article 6 (1) (a) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) The visitor may withdraw its consent to the processing of its personal data at any time.

Meta
